

City of Hastings 2025 Legislative Priorities

Clean & Safe Drinking Water - City Council's No. 1 Priority and Community Concern

- · State Bonding Request PFAS and Nitrates Project
 - Request \$16.6 million for Eastern Wastewater Treatment Plant, one phase of \$68.9 million project
 - City Council resolution on 12/2/24 authorized application for State Bonding Request
- · Support State fronting money for PFAS cleanup, as it is easier for State to recover money through Superfund
- Encourage the Minnesota Pollution Control Agency (MPCA) and Department of Natural Resources (DNR) to include Hastings in the 3M Settlement Agreement
- Support updating the Project Priority List (PPL) and Intended Use Plan (IUP) scoring processes to include additivity of multiple contaminants
- Support federal liability protections for passive receivers (S.1430)

LCCMR Extension

- Support Lake Rebecca Park deadline extension from 6/30/25 to 6/30/26
- Progress delayed due to wet spring/summer in 2024
- Concern for additional delay if wet spring 2025

Local Option Sales and Use Tax

- Reinstate ability for local voters to determine support for sales tax
- Hastings anticipates future Fire Station addition and regional park projects

Local Engagement and Decision-Making

- Oppose state preemption of city zoning and land use authority
- Support local engagement and input on comprehensive planning and development processes
- Need to consider consequences of housing density on existing infrastructure

Narcan Funding

- Tragic impact of opioids on Hastings and Minnesota
- EMS and law enforcement are trained in recognition, response and treatment of drug overdose
- 2023 Standing Naloxone Order and Protocol requires law enforcement to carry naloxone (Narcan)
- Continue funding for purchase of opioid antagonists

Cannabis Regulation

- Support ongoing evaluation of costs associated with legalization of adult-use cannabis
- · Oppose any proposals to diminish local control

E-Bikes

- Support requiring same license/permit as "motorized bicycle" as defined in MS 169.011 subd 45
- Support consistency for alcohol offenses
- · Support requiring helmets for riders under age 18

Met Council Relationship

- Encourage Metropolitan Council Environmental Services (MCES) to decide whether to build new wastewater treatment plant east of Hastings or to pipe Hastings' wastewater to the Empire Township plant
- Delay can impact planning and cost for other projects in the city, including Hwy 61, CSAH 46, CSAH 54, MN Veterans Home and private development.
