

Legislators Visit to Learn About Capital Request for Water Treatment Plants

Removing PFAS from our drinking water remains the city's top priority. Legislative committees visited Hastings on Oct. 28 and Nov. 6 to learn more about water treatment projects that will provide clean and safe drinking water for our community. The city continues to build relationships with state officials and to seek funding for our water infrastructure. Two applications were submitted for consideration in the State's Capital Budget - \$18.3 million for the Eastern Water Treatment Plant and \$22.3 million for the Western Water Treatment Plant. Statewide capital requests will be considered in early 2026, with the hopes that the city's requests are included in a State bonding bill and signed by Gov. Walz. Construction on the Central Water Treatment Plant began in late summer, with the others planned for construction in 2026 and 2027.

2026 Proposed Budget and Preliminary Levy

At its Sept. 2 meeting, the Hastings City Council approved a preliminary 2026 Budget and set a preliminary property tax levy of \$21.7 million to invest in improved water treatment; infrastructure, building and equipment preservation; and personnel. The Council also scheduled a truth-in-taxation public hearing for Monday, Dec. 1 at 7 p.m.

The proposed property tax levy represents an 8.4% increase over 2025. A homeowner with a median value home (\$331,600) will see an estimated annual property tax increase of \$162, or \$13.50 per month, on the city's portion of property taxes.

The proposed levy increase is below most Dakota County cities' early levy projections averaging 10.2% and ranging 5-19%.

"The city continues to invest in clean and safe drinking water, aging roads, necessary building and equipment assets, and our staff," said City Administrator Dan Wietecha.


Preliminary utility rate increases were set at 4.5% for sewer, 4% for stormwater, and a phased increase for water at 10% in January and 10% in July.

The Council also approved a proposed 2026 HEDRA Special Levy subject to the limit of 0.185 percent of the taxable market value. This levy is used for economic development activities that help grow key areas of the city such as the Vermillion Corridor, downtown and the Industrial Park.

New City Website Design Coming Soon!

The City of Hastings is switching website vendors and will launch a redesigned website in December. The new site will be mobile friendly and mobile responsive and meet accessibility guidelines. The site will be completed in phases, with phase 1 launch set for Dec. 11 of this year. Additional content and ADA-compliant text, images and documents will be built out through April of 2027. Those who signed up to receive news alerts will need to re-enroll when the new site launches. The website address will remain as www.hastingsmn.gov.

Highway 61 Project Update and Public Meeting

In 2024, the Minnesota Department of Transportation (MnDOT) completed a study of Hwy 61 through Hastings in partnership with the City of Hastings. The initial assessment provides alternatives to improve safety and mobility through town.

Next up, city and state staff members applied for and received some grant money to help fund the construction and will continue to seek other opportunities to lower their respective cost burdens.

In addition to working on the funding, the state is moving forward with several contracts to supplement the project team, including an engineering firm for design assistance, a general contractor to provide input on construction staging and a communications organization for increased engagement. Design and environmental work will continue through 2027 and include additional outreach opportunities for the public to learn more about the project.

Construction activity is anticipated to kick off in fall 2027 through 2029, with a majority of the work in 2028.

Highway 61 Business Committee

Projects of this scale can bring both challenges and opportunities, and we want to ensure businesses stay informed and supported every step of the way. Follow Your Recycling

If you follow your recycling in Dakota County, you won't have to go very far. The materials are sorted by people and machines at local recycling facilities and sent to different companies that turn them into new products. Many of these companies are based right here in Minnesota, turning recyclables into new cracker and cereal boxes, durable decking and fencing, food and beverage bottles and more. To keep this process running smoothly, it is important to put the right items in your home recycling.

Put these items loose in your home recycling (no plastic bags):

Paper

- Newspaper and inserts
- Magazines and catalogs
- Mail and office papers

Cardboard

- Corrugated cardboard
- Paperboard (e.g., cracker boxes)

Cartons

- Milk and juice cartons
- Soup, broth and wine cartons
- Juice boxes



Metal cans

- Aluminum, tin and steel cans

Glass bottles and jars

Plastic bottles, containers and jugs

- Containers numbered 1, 2 or 5
- Soda, juice and water bottles
- Milk and juice jugs
- Margarine, cottage cheese and other tubs and lids
- Laundry detergent bottles and jugs
- Clear berry and produce containers

Make sure bottles, jars and containers are empty and dry before recycling. They don't have to be perfect — just free of most residue like food and liquids. Leave caps on containers and flatten boxes. Leave out plastic bags, batteries, black plastic, food and things that can tangle around moving machines. If you're wondering about a specific item, use the online Recycling Guide at www.dakotacounty.us, search recycling guide.
