Dear Property Owner/Resident:

This second notification letter serves as a courtesy to inform you the mill and overlay project will begin the **week of May 5th**. In preparation, you will likely begin to see:

- Installation of "Road Work Ahead" signs
- White paint delineating curb and sidewalk replacement
- Paint and flags identifying utility locates

During the first week of the project, crews may:

- Remove and replace selected manholes, catch basins and gate valves
- Remove dilapidated concrete curb and gutter, and re-pour
- Remove the concrete pedestrian ramps on the sidewalks, and re-pour

Please be mindful of the construction workers and exercise caution by driving slow! The City acknowledges the inconvenience and thanks you in advance for your cooperation during this project! There are fifteen streets on this year's project. If they are not working directly in front of your home then please know they are somewhere in town on the jobsite and may be right around the corner.

As mentioned in the first letter:

- Please have garbage and recycling carts curbside by 6am as Tennis Sanitation has agreed to pick up trash by 7am during the project to minimize conflicts. The project will be substantially complete by the end of June.
- Landscaping, including irrigation, is considered "guests" within the Right of Way. It is the responsibility of the homeowner to remove it from the right of way should it be apparent that construction activity will endanger it.


